2. The Rider accepts that Coldblow Equi-Timeshare hereinafter called The Centre, its owners, employees and agents do not accept any liability for any accident, damage, injury to the rider, spectator or other person or property whatsoever.
3. BSI APPROVED HELMETS ARE COMPULSORY. Riders accept that the Centre, it's owners, employees and agents do not accept liability for any accident or injury arising as a result of a Rider not wearing a current BSI approved helmet, properly fitted and fastened in accordance with the manufacturers instructions.
4. It is strongly recommended that the rider wears a body protector when riding, especially for jumping and hacking.
5. The Centre relies on the information given on this form when selecting horses. The centre will take all reasonable steps to ensure that horses selected suit the rider's experience and ability. However notwithstanding this, the rider accepts that accidents can still occur.
6. The Rider accepts full responsibility for the control of the horse and will only ride in a safe and controlled manner.
7. The Rider agrees to adhere to any rules or directional information provided to them.

8. The centre shall not accept liability for injury caused by failure of the Rider to adequately advise the centre of any pre-existing medical condition, which may affect the safety of the Rider, or any other person.
